Please note, that a poor photographic presentation of the submitted products will make a reliable evaluation much more difficult for the pre-jury. It is for this reason that you might no longer be eligible for participating.
- After the end of the return period, the organising team of the pottery market will be selecting the potters, in accordance with the criteria described.

- Applicants whose application cannot be taken into account will be notified by per email by March 2026 the latest. Please note that applications received after the end of the registration period will no longer be taken into consideration.

- The selected participants have to pay:

<b>Market fee</b> for up to 3m selling space	€ 55,00	
Each extra started metre	€ 25,00	
<b>Registration fee</b> for 3 days	€ 320,00	(+13% Mwst.)
(Lump sum for stall rental for 3 days)	€ 150,00	(+20% Mwst)
<b>Photo for the folder</b>	€ 15,00	(+20% Mwst)
<b>Electricity</b>	€ 25,00	(+20% Mwst.)

The registration fee will be earmarked for financing both the supporting events and the promotion material (brochures, posters and stickers).

The decision of the jury is to be applied for 2026 only and has no effect on any entitlements for the following year.

## MARKET ORGANIZATION and INFORMATION

### Purpose and Contents of the 38<sup>th</sup> Austrian Pottery Market: OFFER OF POTTERY HANDMADE IN YOUR OWN STUDIO

Individual stall-designs including the lateral environment belonging to each stall are welcome and may include both floral decorations as well as other individual ideas. Please ensure a clear and visible labelling of the stall (name of the studio etc.). Music, drinks and food are not permitted.

### Organisation:

The market will be held from 28<sup>th</sup> to 30<sup>th</sup> of August 2026 daily from 10 am to 6 pm.

### Assembly and Delivery to the Market:

The stall can be assembled on Thursday, 27<sup>th</sup> of August 2026 **as of 2 pm**. The access to the market area with vehicles for unloading is possible. After unloading, the vehicles have to be removed immediately from the market area.

### Parking:

The vehicles of the pottery market exhibitors may be parked on the specifically intended car park only. (A map of the car park will be sent to you).

In principle, cardboards as packaging material should not be seen on the stalls. All sorts of wrapping can be easily hidden.

### Dismantling of the Market on Sunday, 30<sup>th</sup> of August 2026:

Please note that each hired stall (or stand) must be left clean. All sorts of litter such as packaging material have to be disposed; the immediate vicinity of each stall must be cleaned daily.

At night, the City of Gmunden will provide surveillance from the 27<sup>th</sup> to the 28<sup>th</sup> and the 28<sup>th</sup> to the 29<sup>th</sup> and 29<sup>th</sup> to 30<sup>th</sup> of August 2026 but will not be subject to any liability whatsoever. Therefore, the potters are requested to cover the stalls and/or the goods in the evenings.

### Promotion:

The Culture Dept. of the City of Gmunden will provide for various promotion items such as posters, market-information leaflets etc. This does not rule out that the exhibitors provide their PR-relations with own texts. The distribution of this promotion material is incumbent on the exhibiting studios. The more target-oriented and extensive this work will be done, the more people will visit our market. The Culture Dept. will send information materials to all daily and weekly papers, ceramic journals, museums, tourist boards and coach companies as well as related institutions.
